2. Executive Session

Roxy Fainer motioned and Marie Eldridge seconded for the Board to enter into Executive Session to discuss a matter involving a student that would likely result in the disclosure of public records or the information contained therein as described in Connecticut General Statutes Section 1-210, subsections (b)(2), (11) and (17). Only those invited by the Board may be present in the Executive Session. The Board invites the following individuals into executive session: **Superintendent Francine Coss, Roxy Fainer, Marie Eldridge, Beth Campbell**, Gianni Perugini - Thomaston High School Assistant Principal, Andrea Peters - Director of Pupil Services, Parent of Student I, Grandmother of Student I, Attorney Grello - Board attorney.

3. Potential Action on Matters Discussed in Executive Session - Exit Executive Session at 12:01p.m.

Roxy Fainer motioned and Marie Eldridge seconded that pursuant to Connecticut General Statutes § 10-186 and the discussion held in the executive session, the Thomaston Board of Education concludes that Student I is a resident of the Town of Thomaston, and therefore, should not be denied school accommodations in the Town of Thomaston. Accordingly, Student I shall be provided school accommodations in the town of Thomaston. In the event that Student I or the family of Student I's circumstances change after the date of the final decision in this matter, the Board reserves the right to consider such circumstances and determine whether the residency of Student I or his/her family has changed and take appropriate action, including but not limited to denying school accommodations and seeking tuition reimbursement, as permitted by Law, from the Parent of Student I. Further, the Board authorizes Attorney Grello to communicate in writing the board's decision and the reasons therefore consistent with the board's executive session discussion with Student I and her parent.
