- ALL SCHOOLS OPEN
- HYBRID OF IN-PERSON AND DISTANCE LEARNING

Minimal Spread
Full In-Person with
heightened Health &
Safety Protocols

- IN-PERSON ACTIVITIES PROHIBITED;
SPORTS RESTRICTED OR PROHIBITED

Moderate Spread
Hybrid Model

HYBRID/BLENDED INSTRUCTION

- SMALL, IN-PERSON CLASSES, ACTIVITIES, AND EVENTS
(50% OF STUDENTS IN-PERSON AT ANY ONE TIME)
- STUDENTS COHORT TOGETHER WITH SAME TEACHER AS OFTEN AS FEASIBLE
- MIXING OF COHORTS MINIMIZED
- STUDENTS REMAIN AT LEAST 3 TO 6 FEET APART AS FEASIBLE, SEATED FACING THE SAME DIRECTION
- STUDENTS DO NOT SHARE MATERIALS
- BUS RIDERSHIP REDUCED

FACTORS

- A COMBINATION OF:
 - INDICATORS OF THE SPREAD AND PREVALENCE OF COVID-19 IN THE COMMUNITY
 - AND
 - PHYSICAL AND OPERATIONAL ABILITY OF DISTRICT TO IMPLEMENT CRITICAL MITIGATION STRATEGIES

SOCIAL DISTANCING

- HYBRID INSTRUCTION MODEL
(*SMALL GROUPS*)
- STUDENTS SEATED 3-6 FEET APART
AS FEASIBLE
- CLOTH FACE COVERING
EXCEPT WHEN EATING

- SEATING RESTRICTIONS
- CLOTH FACE COVERINGS
- LOADING/UNLOADING RESTRICTIONS

50% GROUP DETERMINATION

1. SIBLINGS/FAMILIES SHALL BE GROUPED FIRST
2. BALANCING NUMBER OF STUDENTS IN THE TWO GROUPS
 - MONDAY/TUESDAY GROUP (ABOUT 50%)
 - THURSDAY/FRIDAY GROUP (ABOUT 50%)
3. STAFF/PARENT CONFLICTS ADDRESSED AS FEASIBLE WHILE KEEPING 1 AND 2 INTACT

DURATION OF PLAN

- UNLESS COVID-19 SPREAD PERCENTAGES WORSEN, FORCING A CHANGE IN PLAN, THE DURATION OF THE MODIFIED HYBRID/BLENDED INSTRUCTION PLAN WILL BE:
 - *SEPTEMBER 1, 2020 THROUGH OCTOBER 9, 2020*

REVIEW OF PLAN

- UNLESS COVID-19 SPREAD PERCENTAGES WORSEN, FORCING A CHANGE IN PLAN, THE DEADLINE TO DECIDE WHICH PLAN WOULD BE USED AFTER THE MODIFIED HYBRID/BLENDED INSTRUCTION PLAN WOULD BE:
 - *SEPTEMBER 28, 2020*
