# 3. Potential Action on Matters Discussed in Executive Session - Exit Executive Session at 10:29a.m.

Marie Eldridge motioned and Matthew VanOrmer seconded that pursuant to Connecticut General Statutes § 10-186 and the discussion held in executive session, the Thomaston Board of Education conclude that Student E is a resident of the Town of Thomaston, and therefore, should not be denied school accommodations in the Town of Thomaston. Accordingly, Student E shall be provided school accommodations in the Town of Thomaston. In the event that Student E or the father of Student E's circumstances change after the date of the final decision in this matter, the Board reserves the right to consider such circumstances and determine whether the residency of Student E or his father's has changed and take appropriate action, including but not limited to denying school accommodations and seeking tuition reimbursement, as permitted by law, from the Parents of Student E, further, the board authorizes Attorney Grello to communicate in writing the board's decision and the reasons therefore consistent with the board's executive session discussion to Student E and his parents.
