In making such a determination the board reserves the right to seek tuition reimbursement as permitted by the law from the parents of Students G & H based on its findings. Further, the Board authorizes Attorney Grello to communicate in writing the board's decision and the reason therefore consistent with the board's executive session discussion with students G & H and their parents.
