Roxy Fainer motioned the Student will be expelled from attendance at Thomaston Public Schools for a period of one (1) calendar year commencing on February 16, 2024 through February 15, 2025.

- During the period of expulsion, the Student will be provided with an alternative educational opportunity.
- During the period of expulsion, the Student may not be present in school or on school grounds within the district or at school-sponsored activities, whether on or off school grounds, during any portion of the period of expulsion without the express written consent of the Superintendent of Schools or her designee.

The parent of the Student may apply for early readmission to the PATHS High School one (1) week prior to April 1, 2024 for early readmission on April 1, 2024.

Readmission will be based on whether, The Student and the parent of the Student agree to the specific criteria set forth below.

- The specific criteria are the following:
 - o Upon re-entry to school, the Student must hand in his cell phone to the main office on a daily basis.
 - o The Student will limit technology on his Chromebook for only educational purposes.
 - o The Student must participate in a form of therapy agreed to by the Administration in advance of commencement of such therapy. Proof of attendance must be provided to the high school principal.
 - o The Student must participate in meetings with district staff/administration as requested by the Superintendent of Schools or her designee.
 - o The Student will have access to the hallways in the PATHS High School restricted as determined by the high school principal or her designee.

If the Student is permitted readmission, upon his return to school the Student must comply with the following through the end of the period of expulsion (February 15, 2025):

- o The Student will attend school on a regular basis and complete all work and homework assignments in a timely manner as stated in his IEP.
- o The Student will continue to engage in therapy through a period determined by his therapist. Documentation of consistent attendance and participation in therapy must be provided directly to the high school principal by the therapist.

If the Student is readmitted to the PATHS High School, if at any time during the period of expulsion he violates any Board policy or the specific criteria and requirements set forth above, the Board may reinstate the expulsion without a subsequent hearing. If the expulsion is reinstated, the Student will remain expelled for the period through February 15, 2025. **Matthew VanOrmer seconded**.
