Business Report

<u>COVID Related Expenses:</u> At the end of this report is a list of expenditures for the Elementary and Secondary School Emergency Relief Fund (ESSER), the Coronavirus Relief Fund (CRF) and the ARP ESSER Grants from the State of Connecticut.

Non-Lapsing Account: We currently have a balance in the Non-Lapsing account of \$126,798.46.

<u>Oil Tank Removal State Application:</u> Our applications for the removal of our oil tanks was ben denied and we will have to submit another application. The reason given by the State is that the town did not authorize or acknowledge the full amount of the project in their Town Resolution authorizing the projects. The difference was the engineering costs that were included in the application and were going to be paid out of the non-lapsing account. The town has to approve or acknowledge the full amount and then we have to file a new application.

Advanced Physical Therapy Contract: Included for your review is a contract with Advanced Physical Therapy for Sports Medicine for 2023-2024.

Twin Lakes Contract: Included for your review is a contract with Twin Lakes Consulting for a Payroll Specialist for 2023-2024.

BramJam Web Services Contract: Included for your review is a contract with BramJam Web Services for our Thomaston Public School's website for a period of July 1, 2023 – June 30, 2025.

2022-2023 Projection

The 2022-2023 budget projection shows \$47,274 deficit. Salaries are running a deficit because of long-term subs and building subs being hired because Kelly Services cannot provide us with substitute teachers. The deficit in the salary line items has been reduced by not filling open positions by using existing staff to fill the openings. Also, the AFCSME new contract increases were not budgeted for which is causing a deficit in the Non-Certified Wage line item. Employee Benefits is showing a surplus because we have less employees on our insurance than anticipated. Other Professional Technical Services is showing a surplus because of the inability of Kelly Services to provide substitute teachers. Property Services is showing a deficit because of additional utility costs caused by the

increase of electricity rates and the pending asbestos abatement project.
